

TERMS AND CONDITIONS

GENERAL CONDITIONS and PRICE VALIDITY

All amounts herein referred to as \$ mean US DOLLARS. Prices are based on specific days of travel and are subject to limited availability of particular airfare and hotels bookings. A minimum of two nights required. All rates are based on standard rooms and are not valid for New Years, holidays, Carnival and Conventions. The prices in this quote are based on tariffs, exchange rates and airfares in effect at the time of preparation. We reserve the right to alter prices should inflation, cost of services, fuel, labor or material, or exchange rates fluctuate. **Important:** BTT Corp reserves the right to accept or decline any passenger on any trip, before or during the trip should such person's mental or physical condition impede the operation of the tour or the rights, welfare or enjoyment of other tour passengers. In this case, a refund of the unused land services is the limit of the liability to the passenger removed. We also reserve the right to alter or modify the itinerary of any tour if schedules, security matters and/or events beyond our control make such alteration necessary.

BOOKING PROCEDURES

All names with copies of passports must be provided to BTT Corp at time of booking. Packages features and prices for all proposed itineraries are subject to change and are based on availability and price at time of payments. Final documents are generally sent within 15 days prior to departure, provided full payment has been made and all required documents have been received by BTT Corp.

Btt Corp, Inc. will charge a fee of \$300 for printing and mailing vouchers and itinerary.

For all reservations made and confirmed 14 days or less prior to departure the documents will only be delivered by E-VOUCHERS / E- ITINERARY.

PAYMENT PROCEDURES

Booking fee of \$25.00 not refundable will be assessed to confirm availability and prices.

A Deposit of \$150.00 per person is required and must be received by BTT Corp to confirm reservations or check availability.

Additional Deposit imposed on us by our suppliers may be collected and must be received by BTT Corp before due date.

All group bookings will specify additional payment procedures in itinerary proposal.

Full payment must be received by BTT Corp 45 days prior to departure or provision of the service (or according to suppliers terms and conditions and cancellation policies, as applicable), whichever first required.

Payments must be made in cash, money order and certified check or, if made with Visa, Master Card or Amex, a 3.50% fee will be assessed to the full amount and a credit card authorization form must be signed to confirm reservations.

AIR ITINERARY and SEAT ASSIGNMENTS

Flight schedules are not guaranteed. BTT Corp, Inc shall not be liable for any airline schedule changes, delays, cancellations, or any other airline's inability to perform.

Passengers are responsible for reconfirmation of all flights directly with the airlines 72 hours prior to departure. Seat assignment are subject to charges. Free-seat assignments are not guaranteed. If seats selections are not available through Btt Corp, they will be assigned at airport check in.

CHANGES AND CANCELLATIONS

After initial deposit or full payment has been made for land or air packages any changes or cancellations will incur a per person charge, plus any additional airlines, hotels and/or other supplier charges, except for restricted and special package, hotels or services which are non-refundable.

All and changes might affect prices and availability. All existing documents must be returned to BTT Corp. via overnight delivery service and revised documents will be delivered overnight at additional cost of \$150.00

For cancellations and/or interruption of any portion of your tour and services while in progress there is not refund for unused services.

CHANGES OR INTERRUPTIONS, EVEN FOR MEDICAL REASONS, OR OTHER EMERGENCY, MAY RESULT IN A SUBSTANTIALLY HIGHER FARE AT THE CLIENT EXPENSE. TO COVER FOR THOSE CIRCUMSTANCES, TRAVEL INSURANCE IS HIGHLY RECOMMENDED AT TIME OF PURCHASE (see also Disclaimer below).

Penalty fees are per person based on specific days prior to departure or provision of a service or by suppliers' terms and conditions and cancellation policies, whichever is furthest as follows:

Deposit and services that are non-refundable: NO REFUND.

Up to 90 days prior: 25% penalty of the refundable portion of the total package amount.

89 to 45 days prior: 50% penalty of the refundable portion of the total package amount.

44 to 21 days prior: 75% penalty of the refundable portion of the total package amount.

Within 20 days prior: NO REFUND.

AIR CANCELLATIONS AND CHANGES

A fee of \$50.00 will be assessed to clients, plus all airlines fees, to process air tickets refund if the fare is refundable. In other cases, no refund will be given.

A fee of \$50.00 will be assessed to clients, plus all airlines fees for any change made to the reservation. No air refund will be made after a flight is missed or delayed.

TRAVEL DOCUMENTS AND VISAS

All passengers require a valid passport and are responsible for ensuring directly with the correct embassy or consulate that they have the correct visas, documents, vaccinations, parental authorization for traveling minors, and others, as required for travel to foreign countries. BTT Corp assumes no responsibility whatsoever for any passenger travel plans disrupted due to passenger not obtaining required visas, documents, vaccinations, parental authorization for traveling minors, and others imposed by foreign countries.

TAXES, GRATUITIES AND ENTRY FEE

Entry fee to some foreign countries are not included. Some other taxes might apply for air/land packages or services. Gratuities are not included.

All baggage is carried at the passenger's own risk, and BTT Corp, Inc. reserves the right to decline to accept or retain any tour participant. In this case a full refund of unused services will be made, without any further obligation or responsibility. BTT Corp, Inc. accepts no liability or responsibility for costs incurred as a result of passenger failing to obtain the correct travel documents. BTT Corp, Inc. is not responsible for acts or conduct by representatives of US Homeland Security and/or similar agencies of foreign governments.
